- 3. Bidders drop the bids in the Tender Box Placed at TIP office Plot No 181-186, I-92/2 Islamabad
- 4. Bidders must submit their bids as per tender requirement. (Mandatory)
- 5. Price inclusive and exclusive of taxes need to be mentioned separately.(Supplier must be active tax payer otherwise bid will be treated as cancelled).
- Rs. 500,000/- as a bid security in shape of Pay Order/Demand Draft in favor of TIP Haripur in a separate sealed Envelope. Otherwise, bid will not be entertained.
- 7. Bids completed in all respect as per tender/bidding documents and properly filled check list will be considered acceptable.
