Sealed bids are invited from reputable Medical Stores/Suppliers/Company distributor for supply of medicine for TIP Field staff, Retire/Serving (Field Office Karachi) for period of one year extendable. Bidder must be active taxpayer and having medical store near vicinity of TIP Filed Office situated at Near TIP Field Office Karachi.

### Terms & Conditions of Bid

**Tender Procedure: Single Stage Single Envelop Basis.**

1. Bids must be on supplier's letterhead duly signed and stamped.(Mandatory)
2. Discount on medicine in % age.
3. Bidders can drop the bids in the Tender Box Placed at office of GM (SCM) Islamabad.
4. Bidders must submit their bids as per tender requirement i.e. clearly marked as financial proposals (**Mandatory**)
5. Bidder must be active tax payer otherwise bid will be treated as cancelled).
6. Rs. 50,000 as a bid security in shape of Demand Draft, in favor of TIP Haripur in a separate sealed Envelope. Otherwise, bid will not be entertained. Bidder which is already have contract with TIP is exempted.
7. Bids completed in all respect as per tender/bidding documents and properly filled check list will be considered acceptable.
8. Tender form along with bidding documents available on PPRA website.
9. **Bid Validity:** 60 days.
10. Bids complete in all respect should reach the office of the under signed up to 4.11.2025 till 1400 hours and will be opened at 1430 hours on same day.
11. Tender documents will not be issued on the date fixed for opening of bids.
12. Conditional bids shall not be entertained.
13. Tender Documents shall not be issued by Post.
14. Affidavit on stamp paper that the Bidder is not black-listed by any Govt / Authority and is not involved in litigation with any Govt Department / Autonomous Body must be attached with the bids.

**TERMS & CONDITIONS FOR TENDER NO. 06/2025**

1. The contract shall be valid for a period of one year (Extendable) as per mutual agreed Terms & Conditions. In case of unsatisfactory performance, competent authority (CEO TIP) reserves the right to terminate the contract at any stage without assigning any reason.
2. The quotation / bid should be provided on letter head as per FORM OF BID (Specimen Form of bid is available in tender documents). Validity of bid should be 60 days.
3. Sealed bids addressed to GM(SCM) Telephone Industries of Pakistan by referring "**Tender No. 06/2025 for supply of medicines**", should reach on or before 4.11.2025 **up to 1400 Hrs** Tender will be opened on the same day at 1430 Hrs. In the office of HOD Procurement Haripur in the presence of bidders or their authorized persons.
4. Bid security of **Rs. 50,000/- (Rupees Fifty Thousand Only)** in the form of Demand Draft in favour of **Telephone Industries of Pakistan TIP Haripur** must be attached along with the bid which will be returned to the unsuccessful bidders soon after finalization of the tender process. The bid security of successful bidder will be returned after the signing of contract / agreement. Already supplying medicine bidder is exempted.
5. Copies of the following are required to be attached with the quotation:
  - Bidder's CNIC
  - NTN Certificate
  - Drug Sales License (The supplier must have proper Retail shop / Medical Store that may be visited / inspected the Medical Store before signing of the contract.
6. The contractor will intimate the exact address, Telephone No. of medical store / as well as residence address with telephone No.
7. No bid will be considered / entertained if :
  - i. It is received after the specified date and time.
  - ii. The bid is unsigned.
  - iii. The bid is ambiguous.
  - iv. The bid is conditional.
  - v. It is without Bid security of Rs. 50,000/- (Rupees Fifty Thousand only)
  - vi. The bid received with shorter validity than 60 days.
  - vii. The bidder has not mentioned the rebate (% age-Discount) clearly (The offered discount should be on the retail prices). At any instance, if prices quoted in the bills were found higher than retail prices approved by the Ministry of Health, the Competent Authority (CEO TIP) reserves the right to deduct the excess amount charged.
8. The successful bidder have to submit / deposit a **Demand Draft of Rs. 100,000/- (Rupees one Hundred Thousand Only)** in favour of "Telephone Industries of Pakistan Pvt Ltd Haripur" as Performance Guarantee before finalization of contract. The same will be refunded on

successful completion of the contract period. Bank Guarantee / Cheque will not be acceptable as performance guarantee.

9. Terms and condition of the contract will be written on Judicial Stamp paper of worth Rs. 100/= by the contractor, and contract will be signed by the both parties.
10. Medicines shall be supplied by the contractor in such quantities as may be required by the TIP as prescribed by the Medical officer TIP Karachi to employees / workers (Serving & retired) with quantity and type prescribed each time by Medical officer in requisition medical slip.
11. In all emergency cases, the contractor shall ensure to supply the medicines "IMMEDIATELY" at any time during the day or night.
12. In case the contractor fails to supply the ordered items on the same day, purchase will be made on risk and cost basis.
13. The contractor shall submit their Bill to Finance department TIP Haripur through HR&A department on fortnightly basis in the following format along with relevant requisitions slips issued by the Doctor: -
  - a. Serial No of contractor Bill.
  - b. Date of supply (to be indicated against each item).
  - c. Reference No. of Doctor Requisitions slip.
  - d. Quantity of medicines supplied: -
    - i. in Case of Tablets - No of Tablets with potency.
    - ii. In case of Liquids – No of bottles with quantity.
    - iii. In case of Injections – No of Injections with quantity.
    - iv. In case of Gel/Tubes etc --- No & quantities.
14. The medicines supplied will be charged in bill at their retail price. And amount of discount will be deducted from the amount of each bill submitted by the contractor for payment. The contractor will also provide the following certificate along each Bill: -

"Certified that the prices charged in this bill are the authorized retail prices of the medicines supplied".
15. Income Tax / Other Taxes if applicable will be deducted from Contractor Bills as per Govt. Rules.
16. The Competent Authority (CEO TIP) reserves the right to accept or reject any or all the offers, its decision in case of any dispute will be final.
